Dear Mr Pettit

Thank you for your correspondence regarding the Albrecht Oval Lights submission and the suggestion to relocate lights to another location.

Having reviewed the Albrecht Oval Environmental Management Plans (EMP), I made the decision to approve the documents and the framework in which it will operate under.

I note that in the Alice Springs Town Council EMP documents, the Council has agreed that construction, design and operation of the light towers will abide by *Australian Standard 4282*. The specialist lighting report that accompanied the original EDP application identified that the impact of the lights would be able to

meet this standard. As such, any deviation from it would necessitate corrective measures to be undertaken by the Alice Springs Town Council.

While I appreciate a number of concerns you have raised, especially in relation to light spill, I have been advised that the LED lighting technology proposed will allow greater focusing/concentration of light, resulting in less spill compared to traditional technology (e.g. halogen or metal halide).

I am also subsequently of the view that noise levels will be acceptable and traffic will be handled in a respectable manner so long as Council ensures that users of the facility abides by the parameters it has set within its EMP documents.

Given these factors and advice received from the Department of Environment and Natural Resources that if Council adheres to the conditions to the EMPs and *Australian Standard 4282*, then they will likely apply best practice environmental management as defined in the *Waste Management and Pollution Control Act 1988*. I am satisfied that the requirements to grant the EMP have been met.

In noting your concerns, and the need to ensure requirements are strictly adhered to, it is understood that Council has already moved to form the *Albrecht Oval Management Group*, established to monitor risk factors and mitigation of the new lights, which will include membership of three public members. While I am not in a position to make an appointment, I note your interest in this matter and suggest that as a local resident you approach Council with a view to request joining the committee.

I appreciate you bringing your concerns to my attention.

With reference to the subject, and having been a local residents @ 28 Bokhara Street for the past 26 years, located in the immediate Larapinta area & close by to Albrecht Oval, we provide the following comments and formally request further clarifications/responses and additional information from the Commission / NT Dept of Lands & Planning / the Applicants (ASTC) in order to thoroughly and appropriately consider and assess the potential implications and impacts of the rezoning proposal. Also, what exactly the application seeks to achieve, as this is not currently clear from the details provided:

a) THE "EXISTING" & "PROPOSED LAND USES" ARE THE SAME?

Both the Application, and public exhibition notice, as written, state the proposed purpose of the application is to approve/allow the use of Albrecht Oval for "Leisure & Recreation" purposes – refer following screenshot:



The use of Albrecht Oval for "Leisure & Recreation" purposes is already an approved use, as facilitated by EDP18/0007 approval as recently as 2018 – refer following screenshot:

APPROVED PURPOSE

To use and develop the land for the purpose of leisure and recreation and the installation and operation of 4 x 34.5m high lighting towers (ancillary to leisure and recreation), in accordance with the attached schedule of conditions and the endorsed plans.

Q1: Given the above, what is the purpose and intent of this application, as it appears unwarranted and unnecessary?

b) CONTINUING COMPLIANCE

The application states the following (page 1, paragraph 1):

"In order to continually comply with the NT Planning Scheme requirements, the Alice Springs Town Council would like to change the zone to OR (Organized Recreation) which is more appropriate to its current usage"

The subject land was recently (2018) the subject of an EDP application and approval process which allows Albrecht Oval to be used for "Leisure and Recreation" purposes, consistent with its current use.

Q2: Is this not the case?

Q3: If "Yes", why does the land now require rezoning in order to "continually comply" with the NTPS? Q4: If "No", what current "non-compliant uses" (as noted in the applicants Page 16 Summary) does the applicant (and/or the main users AFL / Cricket) intend to continue to utilise the land for in the future?

Additionally, the Applicant recently stated (refer Reference #1) the purpose of the application was to align the use and zoning of Albrecht Oval with the Applicants other similar use sports facilities ANZAC Oval, Ross Park & Rhonda Diano ovals which, they believed, were zoned "OR" (Organised Recreation).

Q5: Given ANZAC Oval, Ross Park & Rhonda Diano ovals are all currently zoned "PS" (Public Open Space), and not "OR" as the applicant previously incorrectly understood, and always have been, is there now any reason to rezone Albrecht Oval? Or,

Q6: Will the applicant be looking to rezone ANZAC Oval/Ross Park/Rhonda Diano Ovals to "OR" (Organised Recreation), the same as Albrecht Oval (all of which are currently zoned "PS"), so that the intended and suggested "compliance alignment" is all in place (ie. so that the "I's" are dotted and "T's" are crossed as the Applicant noted (refer Reference #1)?

c) NORTHERN TERRITORY PLANNING SCHEME (NTPS) & ALICE SPRINGS LAND USE STRUCTURE PLANS (ASLUSP)

The Northern Territory Planning Scheme's current Public Open Space (PS) zoning of Albrecht Oval has been in place since its inception since the mid 1980's when it was originally developed and consistently to date, and as updated <u>as recently as 2020.</u>

The following is quoted from a media statement from Planning Commission Chairman, Mr Gary Nairn, in support of the previous 2016 ASLUSP update:

"Planning Commission Chairman Gary Nairn says the plan establishes future land uses for the Alice Springs region, including surrounding areas from the Joint Defence Facility Pine Gape in the west to Undoolya in the east, Amoonguna in the south-east and the Brewer Industrial Estate and Alice Springs Correctional Facility in the south.

"This is a long-term strategic framework that helps planners, decision-makers and the broader community anticipate and manage future growth and development in the Alice Springs region.

"It integrates strategic land use, transport and infrastructure planning to deliver more sustainable and cost-effective outcomes for the community while safeguarding natural resources for future generations." The Planning Commission commenced discussions with the community in September 2015, with the release of a detailed discussion paper and background investigation report, and a draft plan for further feedback in November 2015. "The response has been terrific, with a wide range of submissions and feedback received. The interest and enthusiasm of residents and the broader Alice Springs community has been heartening."

Our understanding of the purpose and intent of the NTPS and LUSP's is they:

- provide a framework for future anticipated long term, sustainable development;
- inform and enable the orderly consideration, assessment & determination of applications which seek to change the NTPS (ie rezoning applications such as this), and;
- reflect & support business and community expectations, and provide public & business confidence in the Northern Territory Planning Scheme, and its administration, via a well-considered and preplanned, open, transparent and equitable process for all parties engaged with it.

Q7: Given the current "PS" zoning of the land has been in place since its' inception, and deemed appropriate when the Scheme was revised as recently as 2020, could the Commission / Department / Applicant please advise how rezoning now, only months later, will provide public confidence in the NTP Scheme and it's administration? And,

Q8: Has the use & development of Albrecht Oval over the past decade been an ill-advised and badly planned process, inconsistent with the provisions, anticipations and expectations of the past and current NTPS, and its "PS" zoning provisions?

Q9: The Applicant suggests (refer Reference #1) that "....it (Albrecht Oval) should have been zoned "OR" from the begging...". Has this suggestion any "merit" when assessing the proposal against the purpose, intent and provisions of "Public Open Space", as it stands, and the NTG Planning Scheme? Q10: Does the Applicant understand the purpose and intent of providing "Public Open Space" in residential areas/suburbs such as Larapinta, and the social & health benefits of doing so? And, Q11 the implications and potential detrimental impacts of removing the largest area of Public Open Space in the Larapinta and adjacent areas (ie the residential areas west of Bradshaw Drive)? Q12: Does the rezoning of "existing non-compliant developments", in an ad hoc manner to address "non-compliant use" issues, which have been developed inconsistently with the provisions and requirements of both past ¤t planning schemes, and without approval, undermine & erode public confidence in the NTPS, and its accountable administration? As we believe so.

d) THE PRINCIPAL PURPOSE & INTENT OF PUBLIC OPEN SPACE PROVISIONS IN RESIDENTIAL AREAS

As the current 2020 NTPS "PS" Zone Tables state:

4.17 Zone PS – Public Open Space

Zone Purpose

Retain and enrich open space areas for public use and enjoyment, and the enhancement of public *amenity*.

Zone Outcomes

 Public open space enriches the amenity of the surrounding area and primarily caters for the informal outdoor recreation needs of the community.

The purpose of providing Public Open Space is best demonstrated and evident in the contemporary "best practice" planning of Alice Springs newest residential subdivision, The Kilgariff Estate, south of the Gap, where large areas of PS zoned Public Open Spaces (shaded green) are provided – refer following.




Figure 6: Kilgariff Area Plan – West Concept Plan

The Applicant also states (refer application Page 11) the current use and access arrangement relating to Albrecht Oval won't change (refer below).

The issue with this "motherhood" expectation is that it is directly influence by the usage requirement of the sporting bodies (AFL / Cricket) who use it, which can vary over time, as there appears to be no limit on how much actual use by the "sporting bodies" is allowed. Which directly and inversely impacts how much "public access" is allowed/provided.

Only 4 to 5 years ago AFL's winter usage of Albrecht Oval was at a far less level than currently, when it was more evenly shared around (50/50) between the "general public" and "AFL users" on Saturday & Sunday weekend days, when general access is most convenient and sought after by the general public.

Today, "public access" to Albrecht Oval during the winter AFL season is excluded between 10.00am through to around 5.00pm on Saturdays (when used for local AFL Club competition), and between 10.00am through to 6.00pm on Sunday's (when used for remote "Community Cup" competition (note: this is relatively new "usage" development / occurrence).

This application is intended only to streamline the current use. Current arrangements onsite will continue to remain in place. The residents of Alice Springs will continue to be allowed to use the facility for their routine exercise with pets, when the facility is not being used by sporting bodies as per current existing arrangement.

The Applicant even notes the current usage by the "sports bodies" is 98%, compared to 2% by the public!

Q13: Does a rezoning approval to OR, if approved, provide <u>any guarantee</u> that, as stated, current usage and access won't change into the future?

Q14: Can conditions be attached to a OR rezoning approval to provide such guarantees / protections?

From a historical perspective, the Applicant has shown it cannot be trusted to use and operate the space as intended for "Public Open Space" purposes.

This is evidenced by the **current "Horticulture / Plant Nursery" use** of the site which is a "Prohibited" use in the "PS" Public Open Space zone.

As well as the following statement (page 13 of the application) which concedes the current use of the space is, and has not been used / developed compliantly with the past (and current) Northern Territory Planning Scheme provisions (note: this "non-compliance" is NOT a result of the new 2020 NTPS being implemented, as the Applicant appears to believe and has stated on many recent occasions).

Currently with the zone being PS the uses related to this land do not appropriately fit under the scheme. A change in zoning will allow the current use to be compliant to the current requirements of the scheme.

Perhaps the Applicant should find a more appropriate and compliant location to carry out the existing uses?

As there do appears to be other such locations in Alice Springs.

Retrospectively approving a "non-compliant" use, on the basis of "alignment" with the scheme, is not proper administration of the NTPS, and would set a dangerous, slippery-slope precedent for other "non-compliant" users/uses to request similar rezoning's.

Q15: How would such a retrospective, cart-before-the-horse approval process leave the integrity of the NTPS, and influence the general public's & business communities' confidence in its administration?

We have little confidence the Applicant's shown disregard for the purpose, intent and provisions/rules of the NTPS will change into the future, in terms of the Applicant's assurances that the use and current public access provisions won't change in to the future, as stated in the application.

Motherhood type statements which would have absolutely no legally binding status if the space is rezoned 'OR".

As once so, rezoning to "OR" provides an avenue for a further DA application for other "discretionary", "impact" (I) or "merit" assessable uses. Such as a "Licensed Club" or "Licensed Restaurant", both uses which are currently "Prohibited" in the PS" Public Open Space zone. For understandable reasons.

e) CURRENT NTPS ZONE PROVISIONS V PROPOSED

The current "PS" zoning of land "prohibits" the following uses, which rezoning to "OR" would allow with approval as "discretionary" and/or "Impact/Merit assessable" uses via a further, stepping-stone DA application process.

- Licensed Club, or
- Licensed Restaurant

Q16: Should this rezoning application be approved in due course, does the applicant (and/or its main users AFL/Cricket) intend to lodge a further application for any of the above uses?

Q17: If so, which one(s)?

Q18: If the applicant intends to lodge a future application which then requires the issue of a liquor license to support such a use, has the applicant yet consulted with parties / stakeholders that would have an interest in such a future liquor license application (ie Local Larapinta Residents / NT Liquor Commission / CAAC / DAHSA / A/Springs PAAC etc)?

Q19: If the answer to Q16 above is "yes", will the applicant use "OR" rezoning approval (should it be issued) to then base and support a position that the OR (re)zoning of the land anticipates and supports the use of the land as a "Licensed Club" or "Licensed Restaurant"?

The current "PS" Public Open Space zone provides a level of comfort and protection for the general Larapinta and near bye residents, which is implicit in the current zoning use table.

Rezoning Albrecht Oval to "OR" would remove these comforts and protections and allow for uses not previously intended for the space.

Uses which have the real potential to detrimentally affect and impact the residential amenity of the whole Larapinta area.

f) ALIGNMENT WITH THE SPORTS FACILITIES MASTERPLAN

The Applicant submission states the following:

This proposal is in alignment with the Masterplan for Alice Springs Sporting Facilities and is intended to be developed to meet the active sporting and recreational needs of the town, as specified in the masterplan document which provides a long-term vision, developed for the sporting facilities in town. Quote "The Albrecht Oval is one of the four ovals identified to have the potential to be used as a multipurpose facility but lacking in infrastructure to support the town's training and sporting requirements. The provision of sport..."

Q20: <u>All</u> "four" ovals noted above, being ANZAC, Albrecht, Ross Park and Rhonda Diano are currently zoned Public Open Space (PS). Why is the applicant not seeking to also rezone Anzac, Ross Park and Rhonda Dianao Ovals (as well as Jim McConville) given the Applicant's noted intent to "streamline compliance of the use"? Why only Albrecht?

Q21: Would the Commission/ Department support an alternative all inclusive, concurrent application to rezone all 4 noted facilities, in the best interests of efficacy and efficiency, given the Applicant has stated it is looking to rezone all 4 noted ovals (which would save everyone from 3 more similar, single applications and assessment/consideration of such)?

A single, concurrent application across all these facilities would lessen the burden on The Planning Commission & Dept of Lands & Planning, and be in keeping with ASTC's new "efficiency broom" strategy which ASTC is currently seeking to implement via efficiency measures across all Council departments / operations.

g) DEFICIENT COMMUNITY CONSULTATION

The application states (page 1, opening paragraph) that... "The owner has consented to this application".

The "owner" being the Alice Springs Town Council local government body which "owns it" on behalf of the residents and ratepayers of Alice Springs.

The applicant / "owners" / ASTC have carried out NO community consultation on this rezoning proposal. None. The accountable Elected Council Members have not even considered or approved this proposal. Which, given the potential severe impacts on the amenity of surrounding residents, and the value of their housing investments, is

The applicant has also suggested (on recent local ABC Breakfast radio) that by lodging the application, whereby NTG DL&P DAS places it on public exhibition to elicit community responses and feedback in accordance with the NT Planning Act, it has carried out it's consultative obligations.

In doing so, the applicant has completely ignored it own responsibilities to consult with the community (for unknown "operational" reasons) in line with its own **Community Consultation Policy #106** (attached FYI), abrogated all inherent obligations in its own policy to do so, and for want of a better term, handballed its own responsibilities to consult with the community on to the NT Planning Commission and the NT Dept of Lands & Planning.

Q22: Does the Planning Commission / NT Dept of Lands & Planning believe the Applicant has complied with its moral and ethical obligations as a representative Local Government entity to appropriately consult with the local larapinta community/residents, as written in ASTC's Community Consultation Policy #106? And,

Q23: Could the Minister / Planning Commission / NT Dept. of Lands & Planning please request the Applicant revoke / defer the current application until the applicant has carried out proper community consultation in line with its own Community Consultation Policy #106?

h) ALIGNMENT WITH NT REGIONAL LAND USE PLAN 2016?

The Application states (page 13):


"This proposal is in alignment with the objectives of the NT Regional Land Use Plan 2016. As stated in..."

The Northern Territory Planning Scheme, which is supported by and reflects the intent and purpose of the *NT Regional Land Use Plan 2016*, which was updated and reissued as recently as 2020, this year, does not support this statement given the past and current zoning of Albrecht Oval as "PS" (Public Open Space).

This application is therefore **contrary** to "the objectives of the NT Regional Land Use Plan 2016", and the purpose and intent of "Public Open Space" provisions in the Northern Territory Planning Scheme.

i) SPORTS FACILITY v PUBLIC OPEN SPACE & CURRENT USAGE

The following Map (page 11 of application) shows the distributions and locations of existing "Public Open Space" areas and "Sporting Facilities" (note: all are both, except Traeger Park) across Alice Springs:



Should Albrecht Oval be rezoned to "OR", and thereafter morph into "... a similar usage to Trager Park (TIO) stadium which is zoned "OR" (refer application, page 12) this same map indicates there will be no large area of Public Open Space zoned land left in Alice Springs west of Bradshaw/Lovegrove Drive for residents in "the west" to access.

Q24: Can the Planning Commission / NT Dept. of Lands & Planning please advise if the Land Use Structure Pan(s) anticipate(d) this outcome? And, is this potential outcome in line with accepted contemporary, national / international "best practice" planning principles in terms of general recreational "Public Open Space" provisions?

The Application also states "This places Albrecht Oval in a unique location to provide support for much needed sporting facilities to the western part of Town" (page 12)

Q25: Has anyone asked (refer Q20 above) the local community / residents of the area if they want either:

- A) Albrecht Oval rezoned "OR" (Organised Recreation) space and turned into a "much needed" Traeger Park #2 facility (refer application, page 12)? Or,
- B) Albrecht Oval to remain as zone "PS" (Public Open Space) and utilised for equitable, shared use purposes between sporting groups and the local residents?

Additionally, the 2% v 98% numbers/percentages (refer to application, page 10) used by the Applicant to support the position that Albrecht Oval is currently used **"98% of the time by sporting bodies for Organised Recreation"** is both misleading and disingenuous, if not untruthful. These numbers are unrepresentative of the actual situation, and floppy (refer Refence #1), as they only account for "Booked" users of the oval, being the "sporting bodies" (ie AFL/Cricket) who do "book" and use it. The general public **DO NOT** "book" Albrecht Oval, and given it's "Public Open Space" zone and general recreational area zoning, purpose & intent, should not need to.

As so, albeit even as the Applicant "stands by" these figures/percentages (refer Refence #1), we request the Applicants' advised usage numbers/percentages, provided in support of the Applicants position, not be relied upon as being accurate, truthful or a true representation of the current "status quo" usage.

In summary

- 1. There is no purpose for the rezoning, given the proposed "Leisure & Recreation" Land Use is already allowed.
- 2. We believe the current "PS" (Public Open Space) zoning of Albrecht Oval is appropriate, has been so since inception 35 or so years ago, and the "PS" zone still supported by the current, newly minted 2020 Northern Territory Planning Scheme (barely 2 months old).
- 3. It is the only large area of Public Open Space in the Larapinta residential area, west of Bradshaw Drive, available, even currently, on a "limited access" basis (ie there is currently no public access between 10.00am to 6.00pm for 12 weeks on a Saturday/Sunday during winter months whilst AFL use the facility exclusively, for remote "Community Cup" local Club competition purposes, at which times they charge people \$7.00 to enter).
- 4. Should the rezoning to OR / Organised Recreation be approved, and a subsequent DA "Clubroom" application and associated "Liquor License" be approved, Albrecht Oval will become the only licensed premises west of the Gillen Club and a target for break-ins and vandalism. There is no doubt this will eventuate and lead to even further, restricted access to the only large area of Public Open Space in the area west of Bradshaw Drive for families to use for recreational purposes.
- 5. The proposal to rezone Albrecht Oval to OR is ill-conceived, based on past non-compliance of its use and previous mismanaged planning, and is NOT supported by the Northern Territory Planning Scheme or "best practice" planning principles on which the NTPS is, and should be, based.

We therefore respectfully request:

- a) Responses to the above questions, in order to be able to further and appropriately asses the implications and potential impacts of the proposed rezoning. And,
- b) Request this rezoning application be deferred until the Applicant (ASTC) carries out proper and appropriate community consultation with people in the local area (ie those who would bear most of the collateral damage impacts of the proposal into the mid to long term future) in accordance with the written intent and purpose of the Applicants own ASTC Community Consultation Policy #106 (attached for your reference). Or,
- c) this rezoning application be rejected/denied on the basis of "worst practice" ad hoc, retrospective approval, and bad planning processes and principles.

Please also find attached to this submission 2 x petitions in objection to the proposed "OR" rezoning (taken by Fiona Pettit).

Alice Springs Town Council will consult clearly with specified purposes. Consultation will recognise the rights of citizens and stakeholders and Council will listen to all ideas and comments put forward. Information presented to the community will be clear, appropriate and easy to understand.

Consultation will ensure that the needs of a group or an individual will be identified and reflected in the consultation process, and once a decision is made, participants will be informed of the decision and the reasons behind it.

COMMUNITY CONSULTATION FRAMEWORK

July 2005

Introduction

Consultation is an integral part of good governance and Alice Springs Town Council is committed to consulting with the community and stakeholders on matters that directly affect them.

Ensuring that the right consultation processes are put in place for each issue is essential to delivering quality outcomes that provide a level of inclusion and a sense of ownership by relevant stakeholders.

The Alice Springs Town Council is committed to open, honest, accountable and responsible decision making, which facilitates effective communication between Council and the community, encourages community involvement and partnerships in planning and decision making, sets out the steps Council will take in relation to public consultation, and ensures that the most cost effective methods of informing and involving the community which are appropriate for the specific circumstances and consultation topics are used.

Purpose

The Alice Springs Town Council's Community Consultation Framework has been adopted to guide staff in undertaking consultation as well as clearly defining the ways in which the community can be involved in governance and decision making through an effective communication and consultation process.

Council undertakes a range of diverse services, projects and activities. This framework will guide staff in determining the appropriate level of impact of an issue and the appropriate level of community participation required.

Why Consult?

Community consultation is an essential part of the democratic process, and is an informed, 2-way communication process between Council and the community on a particular issue.

Consultation builds community ownership and empowers citizens to actively participate and to assist in developing their community. It provides opportunities for people to influence decisions that may affect their lives and is about gaining input into decision making in partnership relationships.

Principles of Alice Springs Town Council's Consultation Framework

Alice Springs Town Council will consult clearly with specified purposes. Consultation will recognise the rights of citizens and stakeholders and Council will listen to all ideas and comments put forward. Information presented to the community will be clear, appropriate and easy to understand.

Consultation will ensure that the needs of a group or an individual will be identified and reflected in the consultation process, and once a decision is made, participants will be informed of the decision and the reasons behind it.

Inclusive

Consultation will encourage the participation of people affected by or interested in a decision. Affected and interested parties will be given equal opportunity to participate in consultation. Consultation will be sensitive to the needs of particular groups to maximise the ability to contribute. Council will actively seek out people to consult.

Focused

Consultation will be purpose driven, and the chosen consultation methods will be appropriate for the task. A clear statement on what the consultation is to achieve will be provided, as well as what the role of Council and the participants are throughout the consultation.

Responsive

Council will consider and respond to contributions from all participants. Consultation will be transparent, and all people involved will have a clear understanding of how their feedback and comments are to be used. Council will maintain openness and take new ideas on board. Council will ensure respect for the diverse range of interest that may be represented during a consultation and will make reasonable attempt to resolve conflicts if they arise to reach a suitable solution.

Informative

Information relating to the consultation will be readily available to allow participants to make informed and timely contributions. Information can be easily accessed by all involved before key decisions are made, and it will be presented in an easily understood format.

Decisive

All consultations will be evaluated after the decision making to which they contributed to is completed. Participants will receive feedback about inputs received and how the decision was reached. If a difference occurs between the input and the final decision, the reasons will be documented. Council's decision making process will be evaluated after a final decision has been made.

Issues for consultation

There are a broad range of community issues that Council may wish to consult on including:

Site Specific

Issues about a particular site, such as a change in use.

Area Improvement

Matters that affect people in the Central Business District, a suburb or neighbourhood or shopping precinct (e.g. traffic management).

Service Planning

To develop or improve a service which could have an impact on the whole municipality.

Policy Development

To develop or improve policies for Council's position on particular matters which may affect the whole municipality.

Major Projects / Strategic Issues

Projects of such size which impact on the finances or future of the whole municipality.

Strategic Plans

Establishing the decision making framework of council.

Methods of Consultation

Methods of consultation are a means by which the consultation is set up and how information is provided to allow quality consultation to take place. All communication must provide accurate information to both the community and to Council to ensure that the decision making is informed. Methods can include:

Write a Letter

Personally addressed letters to all the affected households, outlining the issues and invites comment, indicating where the comment should be directed within Council.

Survey

Almost always conducted by independent survey specialists and may be done by phone, written survey or doorknock of individual households.

Letterbox Drop

A non-addressed leaflet or flyer that summarises the issues and invites feedback to Council.

Council Newsletter

As a regular publication of Council, it can include articles about a policy or issue. If it is used for consultation, then the article must inform and encourage feedback.

Special Publications

These can range from a special bulletin to a brochure or a draft printed policy.

Advertisements in the Local Newspapers

Advertisements in the news section of the local papers are an important means of advising the community about the matter under consultation and how they might have their say.

Media

Involving distributing media releases and conducting interviews with local journalists.

Community Leaders

Community groups have their own systems of communication. In any consultation, the leaders of those community groups play an important part in circulating information and receiving feedback.

Personal briefing

Held at the request of a member or members of the local community to discuss a particular issue with a responsible officer, perhaps including an Alderman.

Focus Groups / Workshops

Discussion groups of 5-20 people, usually led by a trained facilitator. The participants are invited as residents or because of a particular interest in involvement in the issue. The purpose is to find out the range of opinions that exist on a particular topic. Focus groups cannot measure how widely those opinions are held in the community.

Community Meetings / Forums

With some issues, the community may decide to call a meeting as part of the consultation process.

Public meeting

This may be held at a community venue and invitations can be sent by several methods.

Other methods

Can include setting up steering/advisory committees, expert panels, and email/website based consultation.

Which method?

Consultation methods will vary according to the issue. This consultation chart should be used as a guide only for staff to determine the correct level of consultation on an identified issue.

The Consultation Checklist

This checklist provides a framework for council officers and a reminder of key points of the consultation process. It also provides a means of ensuring that consultations can be properly evaluated. Listed below are examples for inclusion in the checklist.

What is the aim of the consultation?

Ensure that the consultation is targeted and appropriate. There must be a clear statement about what the consultation is to achieve and to ensure objectives sensible, measurable, achievable, realised and timely.

Have the main groups been identified?

Have the secondary groups affected been identified?

Do the groups identified adequately reflect the range of views?

These questions meet the principle of inclusiveness. The way the consultation is set up and administered encourages participation of the appropriate groups who are to be affected by a decision.

How will you ensure that those to be consulted have clear and precise information to make informed comments?

This question meets the principle of providing information. People who are to be consulted must be given sufficient information to assist them to provide informed ideas.

Will the consultation be advertised widely?

Will the main target group be reached by the advertising?

Will the secondary target group be reached by advertising?

Will your plan reach the main target group directly?

Will your plan reach the secondary target group directly?

Are you going to meet your target groups?

How do you know if the process is working along the way?

Will you inform people as to how the information which they provide is to be used? This question meets the principle of responsiveness. It also relates to focus. Council must ensure that its decision making processes are such that they genuinely incorporate consideration of the information gained from consultation, i.e. the decision has not been already made. This in turn must be communicated to the participants in the consultation process.

Will you reach people from non-English speaking backgrounds and from all cultures?

Will you use the appropriate communication tools to reach your target audience?

How do you know if the process worked?

Are there feedback forms to fill in?

Have you prepared mailing lists from this consultation for further research if needed?

Have you developed an evaluation process?

A final step To close the process, send a thank you letter to all people involved in the process, advising them of the decision and any continuing process.

HOW TO DESIGN AND IMPLEMENT A SURVEY

The Australian Government's Statistical Clearing House recommends how to design, implement, and evaluate a survey for the purpose of community consultation.

A manual is available on their website which is a valuable and available tool, and covers the following topics:

Definitions of Concepts used when collected data – Survey, Census, Sample, Unit, Population, sample statistic, mean, variability, variance, standard deviation etc

Survey set up – the importance of, how to identify the key factors in planning the survey, objectives of the survey, the target population, conducting preliminary research, financial and time constraints, existing data sources, case studies, survey design considerations, survey management, advertising, training of staff.

Data Collection Methods – methods of collection, factors affecting the collection, personal interviews, telephone surveys, mail out surveys.

Errors in statistical data – sampling error, variance, non-response

Sample Design – probability and non-probability, sampling, random sampling, size issues

Questionnaire Design – design and development or questionnaire, defining collection objectives, researching the topic, types of questions, answer formats, type of data sought, question wording and response categories, structure and layout of questionnaire

Basic Survey Design – stages in data processing, data capture, editing, analysis, descriptive statistics, condensing data, estimation, measures

Presentation of Results – written reports, statistical presentation, forms of presentation

Confidentiality – factors to consider, types of disclosure, types of confidentiality assurance techniques

I only found out days before the first meeting via the sign on the oval, as opposed to the newly established group. It was emailed/sent to the group prior to its first established meeting on August 11th only days prior without being an allocated agenda item to discuss? Unsure of why that is or not a priority item? Which no agenda was sent for the meeting? Which such tipis was discussed and all 3 local residents dissented to the proposal and lack of consultation, which once I receive the minutes will be making sure was minuteted.

Going forth with my submission into proposed rezoning of Albrecht;

I'm once again disappointed in the lack of community consultation processes that ASTC seems to deliver. I have concerns as a local resident and rate payer for the following reasons;

- public green spaces are far and few in our suburb meaning absolutely non existent apart from albrecht oval.
- public green space eg ovals provide a much needed amenity for local residents to access for pleasure, leasure and family bonding.
- current situations such as COVID 19 mean such spaces are poignant in giving local residents the space to freely engage in activities in open spaces that benefit their physical and mental health requirements to maintain healthy lives and maintain family connections.
- rezoning from public use to organised recreation locks people out of local amenities and green spaces.
- free access to local parks and ovals is required by residents in local areas

Councils are to maintain local parks and ovals for local residents and not remove them for private or organised use.

Residents and ratepayers have rights to freely access parks and ovals In their local areas as public municipality spaces

I have a couple of questions related to such proposals.

Is there a suburb in Alice springs that has more than 1 park/oval to enjoy as public space? I ask this as a suburb 0875 of Alice Springs - this is our only green space oval of this size and such proposed rezoning locks residents out of such an important valuable space.

Why have you chosen in planning to ruin our beautiful suburb with such obscene noise lights and limited Acces to parks?

Would yourself Robert Jennings and co like to come to my house at 38 Bokhara st and view our incredible view from our balcony to see first hand what your proposing to take away from myself and all of the people living around me on the street?

Will council ever be able with public funds to engage in a proper transparent process in involving community in consultations of such significant nature that impacts their ever day lives, mental health and freedom to access local public spaces?

Once agin I'm extremely saddened by the can do attitude of Alice Springs Town Council to submit detailed proposals to planning without consulting local community.

One day I hope to be apart of a committee, local community and be not only a resident but a try payer the council sees worthy of communicating their proposals too.

Very sad to see this happen under the site of a new ceo.

Look forward to a more inclusive transparent approach from council that withdraws such a proposal of rezoning and looks at ways of making our only public green space more accessible to locals and not the majority of alice springs and central Australia living outside the suburbs of 0875.
